
SCHEDULE-C [Statute 19(3)] Clause-11

"No employee shall, except with the previous permission of the competent authority, engage directly or indirectly in any trade or business or any private tuition or undertake any employment outside official assignments. Provided that the above restrictions shall not apply to academic and other related activities mentioned in clause 3 undertaken with the prior permission of the competent authority which may be given subject to guidelines framed by the Board. "

It is, therefore, reiterated that provisions of Rule-15 of Central Civil Services (Conduct) Rules, 1964 and Clause-11 of Schedule-C be strictly adhered to and prior approval of the Competent Authority should be taken in such cases.

I am, further, directed to request you that if any employee is directly or indirectly engaged in any trade or business etc. as mentioned above, he/she should furnish information in this regard latest by 31st July 2019, failing which, it will be presumed that he/she is not engaged in any trade/business etc.

This issues with the approval of Competent Authority.


