- 1. Quotation/bids shall be sent by courier / registered post / speed post and IIT (BHU) will not be liable for any kind of delay.
- 2. The quotation in a properly sealed envelope addressed to The Chief Councillor, Gymkhana IIT (BHU), Varanasi invariably giving on the envelope reference of enquiry and due date of opening.
- 3. Order quantity shall be decided before the event and accordingly the order shall be placed to the lowest eligible and responsive bidder.
- 4. Quotation should have validity of at least till March 31, 2020. Order for Spardha, Kashiyatra and Technex will be provided separately at least a week before the start of the event.
- 5. Firms shall quote separately for each article for which rates are offered as per enclosed format in Annexure-1.
- 6. Quotations must be submitted in single bid format.
- 7. Rates must be quoted in the column "Rate per pc. per day/per sq. ft." mentioned in Anexure-1.
- 8. The rate quoted should be inclusive of all taxes including freight charges, transit insurance & Commercial terms and conditions if any.
- 9. Payment terms: 100% after the satisfactory delivery of services and completion of event and within 20 days after receiving the Invoice/Bill. The payment shall be done through RTGS/NEFT. Kindly provide the following bank details in order to get the payment directly credited to your account:
