- Optical bread board (~ 800 mm X 800 mm)
- Sodium vapor lamp and mount
- Diffuse plate with proper intensity reducing ability
- Two-Three Mirrors (diameter ~ 25-50 mm) and one beam splitter (50 mm X 50 mm, thickness ~ 5 mm, R/T $\sim 50/50$) along with mounts with option for fine tuning / alignment, translation
- CCD/CMOS camera with specification that can give maximum resolution of fringes with the given set up and interfacing with computer. The camera should have other accessories like lens and mount.
- Samples and mounts for refractive index measurements (preferably glass or mica etc.)
