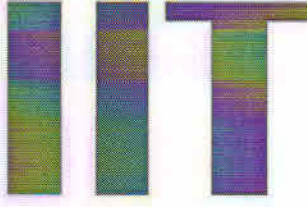

**Subject: Submission of Life Certificate and other certificates-regarding.**

Dear Pensioner/Family Pensioner,

Please find the enclosed format of Life Certificate, Certificate of Re-marriage and self declaration of dependent family members along with the instructions regarding submission of the same to the Pension Section of the Institute.

In this connection, kind attention is drawn towards the fact that, for continuation of payment of pension/family pension, every pensioner / family pensioner of the Institute is required to submit life certificate once a year in month of November, failing which, the payment of pension/family pension may be suspended/stopped. Further, for widow/widower recipient of family pension, certificate of re-marriage is required to be furnished once in case of widow and once every six months in May and November in case of widower.

Therefore, it is requested to furnish the requisite certificate/certificates on or before 30<sup>th</sup> November, 2018 for continuation of payment of pension/family pension.

## Instructions regarding submission of Life Certificate

1. Every pensioner / family pensioner of the Institute is required to submit life certificate once a year in the month of November for continuation of payment of pension/family pension, failing which, the payment of pension/family pension may be suspended/stopped.

2. A pensioner/ family pensioner can report in person with his/her PPO for identification, get his/her life certificate signed by pension disbursing officer of IIT (BHU) and submit it to the Pension Section of IIT (BHU).

3. A pensioner/ family pensioner can also appear in person with his/her PPO for identification and get his/her life certificate signed by any person specified hereunder and send it to the Pension Section of the Institute. In such a case, he/she is exempted from personal appearance at Pension Section of the Institute.

- (i) A person not below the rank of Assistant Professor/Group A officer of IIT (BHU);
- (ii) A person exercising the powers of a Magistrate under the Criminal Procedure code;
- (iii) A Registrar or Sub-Registrar appointed under Indian Registration Act;
- (iv) A Gazetted Government servant;
- (v) A Class I officer of the Reserve Bank of India, an officer (including Grade-II officer) of the State Bank of India.

4. A Pensioner/Family Pensioner who is residing outside India may produce Life Certificate signed by a Diplomatic Representative of India/ an officer of Public Sector Bank situated in the country of residence which is included in the Second Schedule to the Reserve Bank of India Act, 1934.
