Prof. Kripa Shanker joined the meeting, while a presentation on Alumni matter was made by Prof. Rajeev Srivastava, Dean (Reseource & Alumni).

At the outset, the Director extended a very warm welcome to Dr. Kota Harinarayana, the Chairman of the Board of Governors and other members. Then the Director gave his presentation on major achievements of the Institute since the last meeting of the Board in the areas of research grant/sponsored projects received by the Institute, research publications/citation index, patents and MoUs with institutions in India and abroad. The Chairman expressed his happiness on the progress being made by the Institute, particularly the initiative of the Institute for joint PhD programme with IIT Guwahati and an agreement signed with Indian Space Research Organization (ISRO). BoG Resol.No.10.7 Item No.10.7 **CONSIDERED** modification in the BoG Resolution No. 7.48 dated 25.05.2018 to accommodate faculty requirements in the Department of Architecture Planning and Design in the Institute, as per Council of Architecture (CoA) norms.

The members were informed that the Council of Architecture (CoA) registration for 2019-20; 2020-21 and 2021-22 batches (till 3<sup>rd</sup> year of the programme) requires minimum 1 Head at Professor level, 02 Associate Professors and 06 Assistant Professors by default minimum intake of 40 per batches. Only candidates with CoA registration are eligible for Core faculty. Although, the CoA recommends only upto 50 % of the faculty on tenured basis, it may be difficult to recruit regular faculty as per the IIT standard quickly considering the last date of CoA application *i.e* 24-January 2021 for introduction of UG course by new institution.

**RESOLVED** that the following new faculty cadre be approved as a special case, only for two years (maximum) or till regular faculty members are recruited.

BoG Resol.No.10.14 Ex-Agenda Item No10.14 With the permission of the Chair, the Director informed the members that due to unprecedented situation on account of outbreak of COVID-19, the Board at its  $9^{th}$  meeting vide Ex Agenda Item 9.46 considered a special provision for the students whose 5 year period was over in July 2020 and vide its Resolution approved the Maintenance Allowance at the rate of Rs.15,000/- per month for a period of six months only (with no further extension) with an advice to these students to complete their research work within this extended period of fellowship.

Members were informed that there are few students whose 5 year period was over in December 2020 and due to COVID- 19 they had lost crucial time in the final stages of their PhD. The Director proposed that a Maintenance Allowance at the rate of Rs.15,000/- per month for a period of six months only (with no further extension) may be considered for these students from Institute's internal resources. This special provision is a onetime measure, not to be cited as a precedent and no further request from any other batch of students for Maintenance Allowance shall be considered in future.

**RESOLVED** that the aforementioned proposal of the Director be approved.

BoG Resol.No.10.15 Ex-Agenda Item No10.15 Prof. Rajeev Srivastava, Dean (Resource and Alumni) made a presentation on the Alumni Affairs Management in the Institute.
