  - a) all required academic certificates (i.e. marksheets/certificate of 10<sup>th</sup> and 12<sup>th</sup> and T.C./Migration Certificate);
  - b) Category certificate (EWS/OBC-NCL/SC/ST/PwD);
- ❖ Upload "Fee Remission Form" along with a self-attested scanned copy of your parents' income certificate (applicable for those students who belong General/OBC-NCL/ EWS category, whose parents' income (Gross income) is less than or equal to 5.00 lacs per annum), SC/ST/PwD category candidates are not required to upload the parents' income certificate.
